**1. Call to Order**

Bill Bloss called the meeting to order at 6:00 p.m.

**2. Agenda**

The Committee continued their review of the policy manual with the process of reviewing each policy to determine whether further review is needed with possible substantive changes and board approval. If so, they will be flagged for future discussion as noted below. Updates or corrections such as typos that do not constitute a change in policy will be completed by the administrative staff and distributed to holders of the policy manuals. In addition, each policy will eventually say "Reviewed" with date to establish work completed by committee as discussed above.

In this meeting, the Committee continued the review of the 5000 section (Students). With respect to said policies, the Committee determined the following:

1. **5610– Student Insurance Program** – Committee reviewed and recommended removal since there is no statutory requirement to provide student accident insurance. Policy will be presented to the Board for removal at next meeting.
2. **5614 Medicaid Reimbursement** -- Committee reviewed and deemed acceptable as written.
3. **5622 Student Driving/Parking** – Committee reviewed and deemed acceptable as written.
4. **Regulation 5622 Student Driving/Parking** – Committee reviewed and recommended revisions to the "Grounds for Revocation of Permits." Regulation will be presented to the Board at the next meeting.
5. **5617 Physical Force** – Committee reviewed and recommended further review at a later date to ensure compliance with state and federal law. The committee also recommended the development of a reporting form as a regulation.
6. **5714 Search and Seizure** - Committee reviewed and recommended further review at a later date to ensure compliance with state and federal law

7. **Regulation 5714 Search and Seizure** - Committee reviewed and recommended further review at a later date to ensure compliance with state and federal law
8. **5718 Police in Schools** - Committee reviewed policy and recommended amended language *Building administrators will work with police to assure that police intervention will have minimal disruption to the school day* in place of the first two paragraphs. The committee recommended removal of item #3 and further revisions were recommended for the last paragraph. Revised policy will be presented to the Board at next meeting
9. **5722 Student/Probation/Police/Courts** – Committee reviewed and recommended further review at a later date.
10. **5810 Professional Research and Publishing (Policy and Regulation) --** Committee reviewed and recommended further review at a later date.
11. **5814 Freedom of Speech/Expression --** Committee reviewed and recommended further review at a later date.
12. **5818 – Surrogate Parent Program** - Committee reviewed and recommended removal since information is covered in state statutes and it is not necessary to have a policy reiterating/redundant. Policy will be presented to the Board for removal at next meeting

The committee will review the 6000 (Instruction) section at its next meeting.
